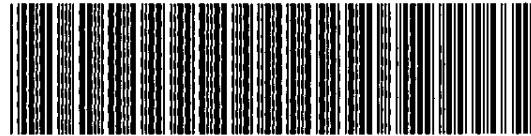


1. The date of the filing of the articles of organization was November 8, 2011.
