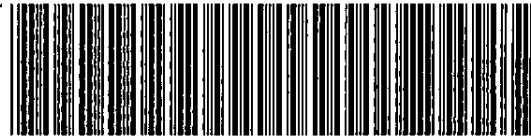



**ARTICLES OF ORGANIZATION
OF
A STEP ABOVE POOL CARE & MAINTENANCE, LLC**

ARTICLE I

NAME

The name of this Limited Liability Company is A Step Above Pool Care & Maintenance, LLC (the "Company").



PURPOSE


This Company is organized for the purpose of transacting any and all lawful business.

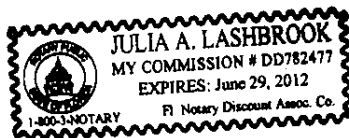
