

**ARTICLES OF ORGANIZATION OF
JR's GUIDE SERVICE, LLC**

(Pursuant to Section 608.407, Florida Statutes)

ARTICLE I - NAME

The name of the limited liability company is JR's GUIDE SERVICE, LLC.

ARTICLE II - ADDRESS

The mailing and street address of the company is 23485 U.S. 98 West, Lamont, Florida 32336.

ARTICLE III - PURPOSE

The company has been organized for commercial development and any other lawful business.

ARTICLE IV - INITIAL MEMBERS




