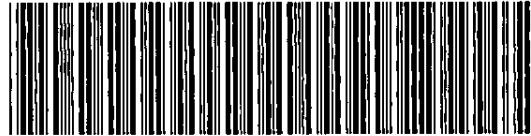

ARTICLE III - DURATION




