**ARTICLES OF ORGANIZATION
OF
SMART STARTS AT DADELAND LLC**

The undersigned, being a duly authorized representative of the members, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

**ARTICLE I
NAME**

The name of the limited liability company is **SMART STARTS AT DADELAND LLC** (the "Company").

**ARTICLE II
ADDRESS**

The principal and mailing address of the Company is 7800 SW 96th Street, Miami, FL 33176.

**ARTICLE III
REGISTERED AGENT AND OFFICE**

The Company designates 7990 SW 117th Avenue, Suite 210, Miami, FL 33183 as the street address of the initial registered office of the Company and names Alejandro Garcia as the Company's initial registered agent at that address to accept service of process within this state.

**ARTICLE IV
DURATION AND CONTINUATION**

The period of the Company's duration shall commence with the filing of these Articles of Organization with the Secretary of State, and shall continue perpetually, unless terminated (i) in accordance with the Company's Operating Agreement, or (ii) by the written agreement of a majority of ownership interest.

The Company shall be conducted, carried on, and managed by at least one (1) Manager and is, therefore, a manager-managed Company. The Manager(s) shall also have the rights and responsibilities described in the Operating Agreement of the Company, if applicable. The purpose for which the Company is being formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida including activities within the United States and abroad.


ARTICLE VII
