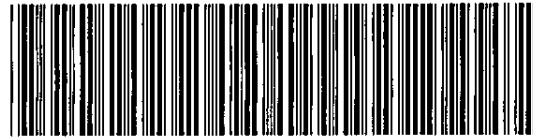

1. **NAME**

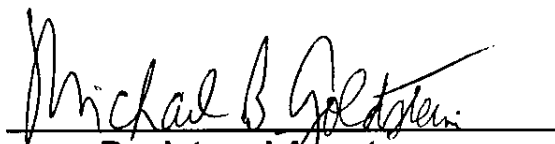
