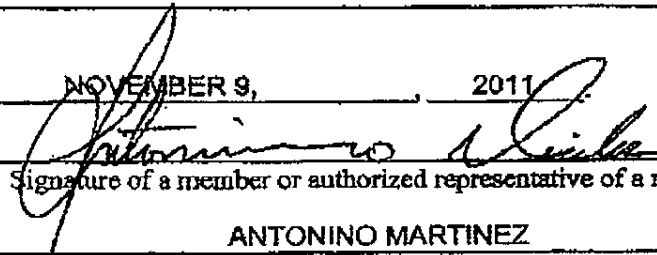

Article XI

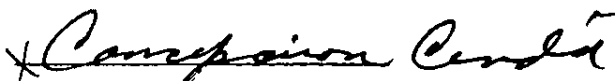
Continuity of Life

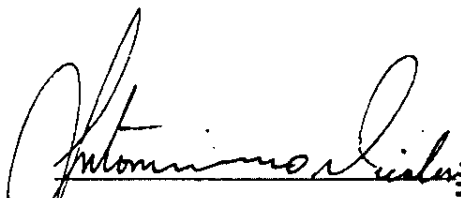
