Management

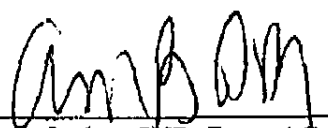

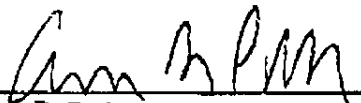
