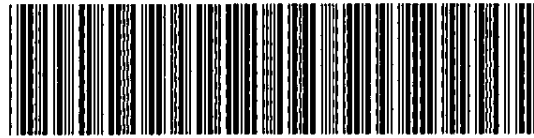

ARTICLE I  
NAME

The name of the limited liability company is "USDV/Pan, LLC" (the "Company").

ARTICLE II
