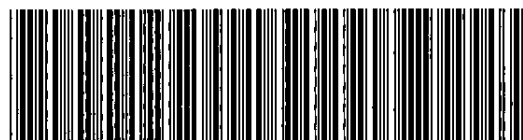

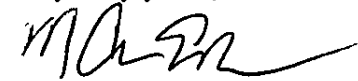

## **ARTICLES OF ORGANIZATION**

**OF**

**LPMD, P.L.**

The undersigned, for the purpose of forming a professional limited liability company under the Florida Professional Service Corporations and Limited Liability Companies Act, F.S. Chapter 621, and the Florida Limited Liability Company Act, F.S. Chapter 608, as applicable and to the extent not in conflict with Chapter 621, hereby makes, acknowledges, and files the following Articles of Organization.

### **ARTICLE I - NAME**

The name of the limited liability company shall be **LPMD, P.L.** ("Company").

### **ARTICLE II - ADDRESS**

The mailing address and street address of the principal office of the Company shall be 335 Eagle Drive, Jupiter, FL 33477.

### **ARTICLE III - PURPOSE**

The Company shall be authorized to engage only in the rendering of professional medical services, and in any other related purpose authorized by Florida Statute, Chapter 621.

### **ARTICLE IV - DURATION**

The Company shall commence its existence on the date the Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual unless the Company is earlier dissolved as provided in the Operating Agreement.

### **ARTICLE V - REGISTERED OFFICE AND AGENT**

The initial Managers of the Company shall be:

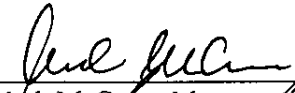

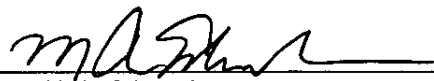
