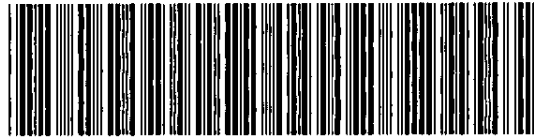


ARTICLE I. Name: The name of the Limited Liability Company is RG Deerfield, LLC (the "Company").


