

1. Name. The name of this professional limited liability company is DENNIS L. ROBICHAUD PLLC, a Florida professional limited liability company (the "Company").
2. Duration. The Company shall have perpetual existence commencing on the filing of the Articles of Organization with the State of Florida and continues even though a membership of a member is terminated.
3. Purpose. The Company is organized to hold and manage real property, transact all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida, including professional real estate services. The Company is organized for the purpose of providing professional real estate services.

Operating Agreement of the company as defined in Section 608.402(24) of the Florida Statutes must be in writing and signed by the initial members.


