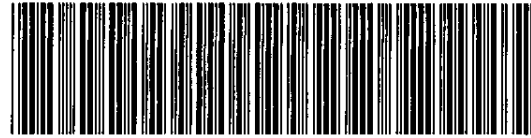



Name
