**ARTICLES OF ORGANIZATION  
OF  
EDIFICA CONSTRUCTION, LLC.**

The undersigned, being a duly authorized representative of a manager, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

**ARTICLE I**  
**NAME**

The name of the limited liability company is **EDIFICA CONSTRUCTION, LLC** ("The Company").

**ARTICLE II**  
**ADDRESS**

The principal office and mailing address of the Company is as follows: 770 Claughton Island Drive Apt 704 Miami, Florida 33131.

**ARTICLE III**  
**REGISTERED AGENT AND OFFICE**

The Company designates 770 Claughton Island Drive Apt 704 Miami, Florida 33131, as the street address of the initial registered office of the Company and names **Elisa Larrain** as the Company's initial registered agent at that address to accept service of process within this state.

**DURATION AND CONTINUATION**

The period of the Company's duration shall commence with the filing of these Articles of Organization with the Secretary of State and shall continue perpetually, unless terminated (i) in accordance with the Company's Operating Agreement, or (ii) by the written agreement of a majority of ownership interest.

The purpose for which the Company is being formed is to engage in any activity or business permitted under laws of the United States and the State of Florida.


**ARTICLE VII**
