# ARTICLES OF ORGANIZATION · OF

THE SECTION OF STATE DAVID A. HERNANDEZ D.D.S., P.L.

The undersigned person hereby adopts these Articles of Organization in order to form a professional limited liability company under Chapters 608 and 621, Florida Statutes.

#### <u>ARTICLE I – NAME</u>

The name of this limited liability company shall be DAVID A. HERNANDEZ, D.D.S., P.L. (the "Company").

#### ARTICLE II – DURATION

The Company shall commence upon the execution of these Articles and shall exist perpetually.

#### <u>ARTICLE III – PURPOSE</u>

The purpose of the Company is to engage in the profession of dentistry.
