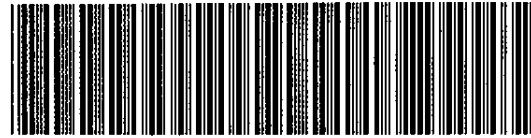

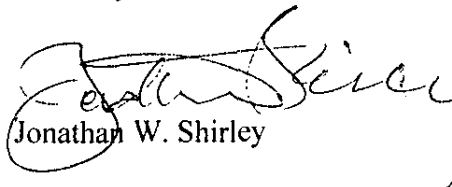

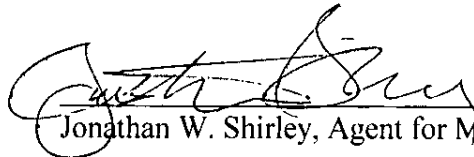

The Company shall be Manager managed and the initial Manager shall be Denise Masson.

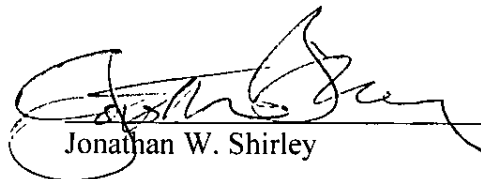
ARTICLE VII
