

ARTICLES OF ORGANIZATION OF REST GROUP, LLC

THE UNDERSIGNED hereby certify that he intends to form a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit. The undersigned further declare that the following Articles shall be the Charter and authority for the conduct of business of such limited liability company.

ARTICLE I

The name of the limited liability company (the "Company") shall be REST GROUP, LLC

ARTICLE II ADDRESS

ARTICLE VII ADMISSION OF NEW MEMBERS

ARTICLE VIII CONTINUATION OF BUSINESS OPERATIONS

The Company may continue its business operations upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in a limited liability Company only upon the unanimous approval of the remaining Members, unless otherwise provided in the Company's Operating Agreement.

ARTICLE IX TRANSFERABILITY OF MEMBER'S INTEREST

A Member's interest in the Company shall not be transferred unless the transfer is approved by the Members in accordance with the Company's Regulations.
