PLAN OF MERGER

THIS PLAN OF MERGER (this "Plan") is effective as of February 1, 2012 (the "Effective Date"), by and between Tampa Health Care Associates, LLC, a Florida limited liability company (the "Non-surviving Entity"), by resolution adopted by its sole member on or prior to February 1, 2012, and 2916 Habana Way Operations LLC, a Florida limited liability company (the "Surviving Entity"), by resolutions adopted by its sole member on or prior to February 1, 2012.

WHEREAS, the Non-surviving Entity desires to merge with and in Surviving Entity, with the Surviving Entity surviving the merger (the "Merger");
