The undersigned, acting as organizers of this limited liability company pursuant to Chapter 608 of the Florida Statutes, hereby form a limited liability company under the laws of the State of Florida and adopt the following *Articles of Organization* for such limited liability company:

ARTICLE I - NAME OF COMPANY

The name of the limited liability company is NSC & PAC, LLC (the "Company").
