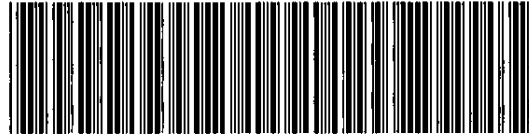



**Article I
Name**

The name of the limited Liability Company shall be Affordable Cremation and Funeral Services Network, LLC.

Article II

Initial Registered Agent and Office

**Article III
Corporate Address**

The principal place of business and mailing address is 2067 1st Avenue North, St. Petersburg , FL 33713. However, the corporation may establish offices in other locations, from time to time, as it deems necessary. The corporate mailing address is 2067 Avenue North, St. Petersburg , FL 33713.

Article IV

Duration

The Company's existence shall terminate no later than 99 years from date of commencement, unless the Company is dissolved pursuant to these Articles of Organization.

**Article V
Purpose**

The general purpose of the Company is to engage in the business of cremations and funeral services and to engage in and transact any lawful business that a limited liability company may undertake under the laws of the State of Florida.

**Article VI
Dissolution**

The Company shall be dissolved upon the death, retirement, resignation, expulsion, or bankruptcy of a Member or Manager or upon the occurrence of any other event that terminates a Members continued membership in the Company, unless the remaining Members unanimously consent to continue the business of the Company.
