ARTICLES OF ORGANIZATION FOR ST. LUCIE MINING PARTNERS, LLC

A FLORIDA LIMITED LIABILITY COMPANY

The undersigned, acting as the organizer of St. Lucie Mining Partners, LLC, under the Florida Limited Liability Company Act, Chapter 608, Fla. Stat., adopts the following Articles of Organization:

ARTICLE I NAME

The name of the limited liability company is:
