ARTICLE I

Name

The name of the limited liability company shall be **Future Solutions II, LLC**.

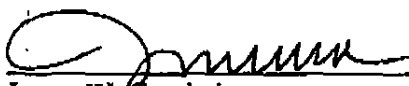
ARTICLE VIII

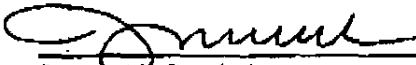
