

ARTICLES OF ORGANIZATION  
OF

The undersigned, being a member of a limited liability company to be organized under the Florida Limited Liability Company Act, adopts and submits the following Articles of Organization for such limited liability company:

Article I  
NAME

The name of the limited liability company (the "Company") shall be:

INITIAL MATTERS

The Company will be managed by a manager or managers, who shall be designated, appointed or elected as more fully described in the Regulations. The initial number of managers of the Company shall be one (1). The number of managers may be increased or decreased in accordance with the terms of the Regulations. 




