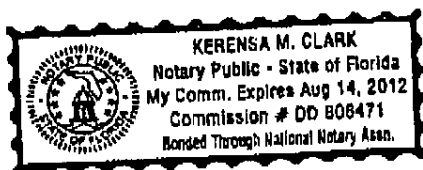
- a. The name of the limited liability company is K & B Residential Rentals, LLC.
