- c. The Articles of Organization are amended to provide that the name of the limited liability company will be K & B Commercial Rental's #1, LLC.

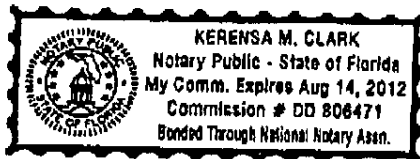
