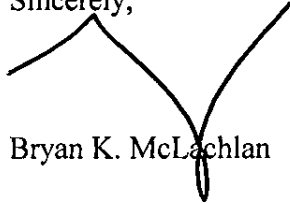

ARTICLES OF ORGANIZATION

OF

ARTICLE I.

The name of this limited liability company is EXPERT 123 L.L.C.

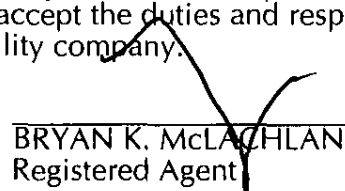
