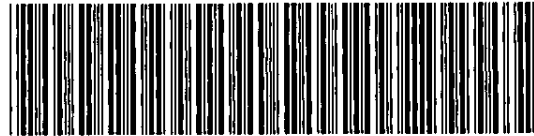

**ARTICLES OF ORGANIZATION
OF
AVIATION REGISTRATION PARTNERS, LLC**

The Articles of Organization following are adopted for the purpose of organizing a Company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes.

ARTICLE I

Name and Address of Company

The name of the limited liability company is Aviation Registration Partners, LLC, and its street and mailing address is 1350 Market Street - Suite 205, Tallahassee FL 32312.

ARTICLE II

Commencement and Duration of Company

The Company shall exist from the date of filing these Articles with the Florida Department of State until the occurrence of any of the events specified in Section 608.441, unless continued by the unanimous consent of all of the remaining members.

ARTICLE III

Management

William D. Crona, with offices at 1350 Market Street - Suite 205, Tallahassee FL 32312, shall serve as the Company's initial General Manager until the first annual meeting of the membership or until his successor is elected and qualified. Thereafter, the Company will be managed by a manager or managers elected annually, as provided in the Company's Operating Agreement and Regulations.

ARTICLE IV

Admission of Additional Members

Additional members may be admitted to the Company if all the current members agree to the admission of the additional members and to the terms of such admission.

ARTICLE V

Termination of Membership

If a member of the Company dies, retires, resigns, is expelled, declared insane, becomes bankrupt, is dissolved or upon the occurrence of any other event which terminates

Registered Agent and Office

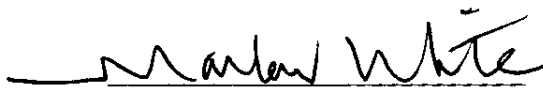
The Company's initial registered agent is William D. Crona; the street address of the Company's initial registered office is 1350 Market Street - Suite 205, Tallahassee FL 32312.

Operating Agreement and Regulations

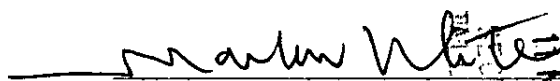
