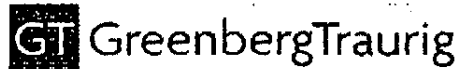

ARTICLE II - Address

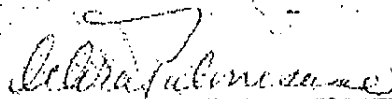
