

**ARTICLES OF ORGANIZATION
OF
DOUBLE D EXCURSIONS, LLC**

ARTICLE I

Name

The name of the limited liability company ("Company") is DOUBLE D EXCURSIONS, LLC.

ARTICLE II

Address

ARTICLE III

Registered Agent and Office

ARTICLE V

Admission of New Members

ARTICLE VI

Continuation of Business

The remaining members of the Company have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company. The business may be continued only on the unanimous written consent of the remaining members.

ARTICLE VII

Indemnification

To the greatest extent not inconsistent with the laws and public policies of Florida the Company will indemnify, as a matter of right, any Member made a party to any proceeding because he or she is or was a Member, against all liability incurred by such individuals in connection with any proceeding; provided that such individual has met the standard of conduct for indemnification set forth under Florida law.

ARTICLE VIII

Additional Provisions

The power to adopt, alter, amend or repeal the regulations of the Company is vested entirely in the members.


