FILED PH 2:3 The undersigned, an authorized representative of a Member, desiring to form a lighter liability company under and pursuant to Florida Statute 608, entitled the Florida Limited Liability Company Act, does hereby adopt the following Articles of Organization for such company:

ARTICLE I - NAME
