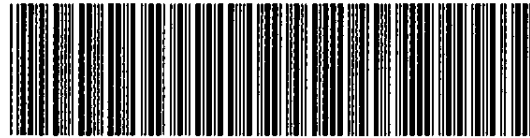

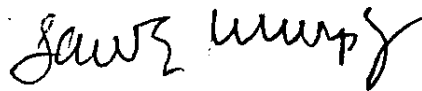

The undersigned (the Member), for the purpose of forming a single member limited liability company under Chapter 608 of the Florida Statutes (the Act), hereby sets forth the following:

ARTICLE I- NAME

The name of the limited liability company is GEC COLLECTIONS, LLC (the Company).

The Company shall commence its existence on the date these Articles of Organization are filed with the Florida Department of State.
