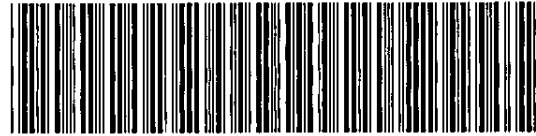

ARTICLE 1 - NAME

The name of the limited liability company shall be **DOMINQUE AND DAVID HACCOUN INVESTMENT I LLC** ("Company").

ARTICLE 2 - ADDRESS

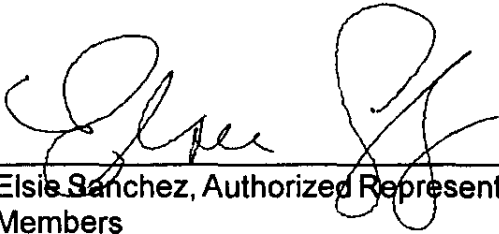

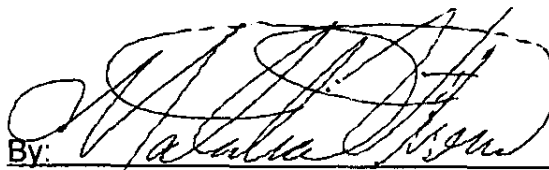
