ARTICLES OF ORGANIZATION

OF

BENEFICIAL KERRVILLE SENIOR APARTMENTS LLC

The undersigned acting as the organizer of BENEFICIAL KERRVILLE SENIOR APARTMENTS LLC under the Florida Limited Liability Company Act, Chapter 608, <u>Fla. Stat.</u>, adopt the following Articles of Organization:

ARTICLE I - Name:

The Company reserves the right to amend any provision of these Articles of Organization, which amendment shall only be effectuated in accordance with the terms of the Operating Agreement of the Company.

ARTICLE IX - Indemnification:

Any repeal or amendment of this Article by the Members of the Company shall not adversely affect any right or protection of a member, manager or officer existing at the time of such repeal or amendment.
