ARTICLE I

The name of the Company is Bunch of Loaners, LLC.

ARTICLE II

The mailing address of the Company is c/o Elaine K. Beers, 4500 Riverside Drive, Palm Beach Gardens, FL 33410.

ARTICLE III

The Company and the duration of its existence shall commence upon the filing of these Articles and shall continue indefinitely unless sooner terminated in accordance with the provisions of the Operating Agreement.

ARTICLE IV

The member or members shall forthwith execute and record an amendment to the Articles of Organization to evidence such continuation, if required by appropriate governing law.

ARTICLE VII

A member may not assign or transfer any portion of his or her interest in the Company without the prior written, unanimous approval of each member and then only in accordance with the

ARTICLE VIII

The net profits and losses of the Company for any year shall be allocated among the members in accordance with the Operating Agreement.


