**ARTICLES OF ORGANIZATION
OF
BAVARO HOLDINGS, LLC**

The undersigned authorized representative of a member of the captioned Limited Liability Company, under the provisions of the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, adopts the following Articles of Organization:

ARTICLE I

Name, Mailing Address and Purpose of Organization

The name of this limited liability company is Bavaro Holdings, LLC (the "Company"). The Company's principal address and mailing address is 514 N. Franklin Street, Suite 101, Tampa, FL 33602. The Company's initial registered agent is David M. Jeffries, whose address is 1227 N. Franklin Street, Tampa, Florida 33602. The Company is organized to enable its members to transact any lawful business for which a limited liability company may be organized under Florida law.





REGISTERED AGENT**


