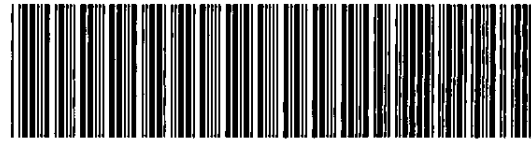

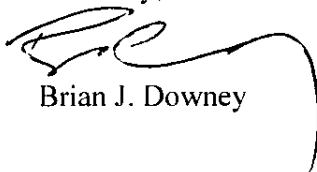

1. Name. The name of this limited liability company is PERSONAL TOUCH HOME SERVICES, LLC, a Florida limited liability company (the "Company").

2. Duration. The Company shall exist for a term commencing on the filing of the Articles of Organization with the State of Florida and continues until January 1, 2090.

3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida, including providing home maintenance and repair services, and such other lawful activities as are reasonably necessary, convenient or incidental to this purpose.

9. Certificated Interests. The members' interests in the Company may be evidenced by certificates.

10. Members' Rights. Pursuant to section 608.4235 of the Florida Statutes, no member of the Company other than the managers shall be an agent of the company solely by virtue of being a member, and no member other than the managers shall have authority to incur debt or contractual liability on behalf of the company solely by virtue of being a member. Any Operating Agreement of the company as defined in section

608.402(24) of the Florida Statutes must be in writing and signed by all the initial members.

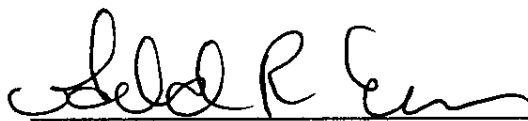
