ARTICLES OF ORGANIZATION

ARTICLE I - NAME

The name of this limited liability company is:

ARTICLE V - PLACE OF BUSINESS

The mailing address and the street address of the principal office of the company is 1399 Church Street, Decatur, GA 30030.

ARTICLE VI - ADMISSION OF ADDITIONAL MEMBERS




ACCEPTANCE OF REGISTERED AGENT
