BLANCHARD, LLC, hereby presents these Articles of Organization as the Articles of Organization of K. L. BLANCHARD, LLC, a limited liability company formed under the provisions of Chapter 608, Florida Statutes.

ARTICLE I - NAME

The name of the limited liability company is:
