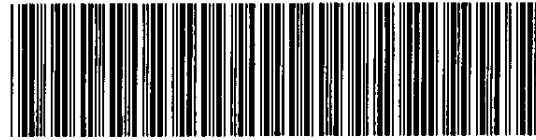

ARTICLES OF ORGANIZATION OF

ROBERT BOSS LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be **ROBERT BOSS LLC** ("Company").

ARTICLE 2 - ADDRESS

ARTICLE 3 - EFFECTIVE DATE

These Articles of Organization shall be effective the 1st day of January, 2012.

ARTICLE 4 - DURATION

Subject to the provisions of Article 8, the Company's existence shall terminate no later than 99 years from its date of commencement, unless the Company is earlier dissolved as provided in these Articles of Organization.




