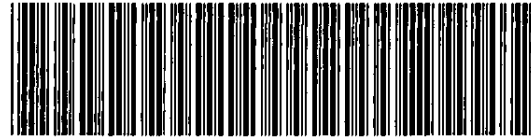



ARTICLES OF ORGANIZATION
ROPA RESTAURANT GROUP, LLC
A LIMITED LIABILITY COMPANY

1. **Name.** The name of the limited liability company is ROPA RESTAURANT GROUP, LLC.
2. **Purpose.** The purpose of this limited liability company is operate and manage a restaurant and may include the transaction of any and all lawful business for which limited liability companies may be organized in the state of Florida.
3. **Address of Principle Office.** The address (mailing and street address) of the registered office of the limited liability company is 1200 S. Pennsylvania Avenue, Winter Park, FL 32789.
4. **Term.** Term of this LLC shall be perpetual.
