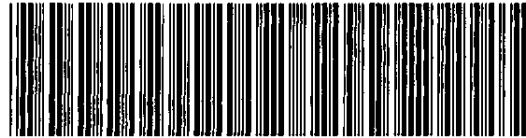

**ARTICLES OF ORGANIZATION OF NANCY C. HARRISON, ESQ., P.L.
(PROFESSIONAL LIMITED LIABILITY COMPANY)**

The undersigned certify that we have associated ourselves together for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit. We further declare that the following Articles shall serve as the Charter and authority for the conduct of business of the limited liability company.

ARTICLE I. NAME AND PRINCIPAL PLACE OF BUSINESS

The name of the limited liability company shall be Nancy C. Harrison, Esq., P.L., and its principal office shall be located at 599 Atlantic Boulevard, Suite 5, in the City of Atlantic Beach, County of Duval, State of Florida, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.

ARTICLE II. PURPOSES AND POWERS

This Professional Liability Company is organized for the following purposes:

- a. To engage in the practice of law as a professional limited liability company and to carry on services incident to the practice of law. The practice of law is the sole and exclusive professional service to be rendered by this limited liability company.
- b. To own property, enter into contracts, and to carry on any business necessary or incidental to the accomplishment or furtherance of the purposes or objects of this corporation.
- c. To engage in any activity or business authorized under the Florida Statutes.

ARTICLE III. EXERCISE OF POWERS

All limited liability company powers shall be exercised by or under the authority of, and the business and affairs of this limited liability company shall be managed under the direction of, the members of this limited liability company. This Article may be amended from time to time in the regulations of the limited liability company by a unanimous vote of the members of the limited liability company.

ARTICLE IV. MANAGEMENT

Management of this limited liability company is reserved to its members, whose names and addresses are as follows:

ARTICLE V. MEMBERSHIP RESTRICTIONS

Members must be duly licensed or otherwise legally authorized to render legal services. Membership will be restricted in accordance with Chapter 621, Florida Statutes.

Members shall have the right to admit new members by unanimous consent. Contributions required of new members shall be determined as of the time of admission to the limited liability company.

A member's interest in the limited liability company may not be sold or otherwise transferred except with the written consent of all members.

On the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or the occurrence of any other event that terminates the continued membership of a member in the limited liability company, the remaining members shall have the right to continue the business on unanimous consent of the remaining members. Limitation on issuance and transfer of ownership shall be in accordance with Section 621.09, Florida Statutes. Disqualification of members shall be in accordance with Section 621.10, Florida Statutes.

ARTICLE VI. CAPITAL CONTRIBUTIONS

Capital contributions in the amount of \$10.00 and other valuable consideration shall be paid to the limited liability company by the originating member. Initial contributions will be made as required for investment purposes, as determined by unanimous consent of the members. Thereafter members will make additional contributions in equal shares.

ARTICLE VII. PROFITS AND LOSSES

(a) Profit Sharing. The members shall be entitled to the net profits arising from the operation of the limited liability company business that remain after the payment of the expenses of conducting the business of the limited liability company. Each member shall be entitled the distributive share of the profits as specified from time to time by consensus of the membership.. The distributive share of the profits shall be determined and paid to the members each year on the anniversary date of the commencement of business of the limited liability company, the month and day of the commencement date being the filing date of these articles with the Secretary of State for the State of Florida.

(b) Losses. All losses that occur in the operation of the limited liability company business shall be paid out of the capital of the limited liability company and the profits of the business, or, if these sources are insufficient to cover such losses, by the members in proportion to their pro rata share of profits above.

ARTICLE VIII. DURATION

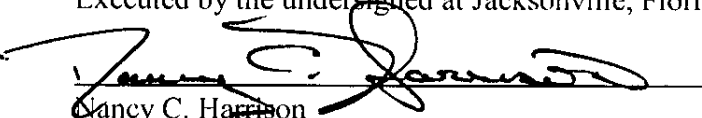
This limited liability company shall have perpetual existence, or until dissolved in a manner provided by law, or as provided in the regulations adopted by the members.

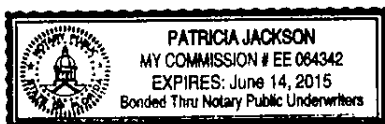
