ARTICLES OF ORGANIZATION

FOR

Pursuant to Chapter 608 of the Florida Statutes, the undersigned, being an authorized representative of the sole member, executes and adopts the following Articles:

ARTICLE I -NAME

The name of this limited liability company is **Miromar Lakes Golf Club, LLC**, a Florida limited liability company (the "Company").
