

ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF TVP RESTAURANTS, LLC (a Florida limited liability company)

Pursuant to Section 608.411, Florida Statutes, TVP RESTAURANTS, LLC, a Florida limited liability company (the "Company"), hereby adopts the following Articles of Amendment:

FIRST:

The Articles of Organization of TVP RESTAURANTS, LLC, a Florida limited liability company, were filed on December 20, 2011, and assigned document number L11000142783.

SECOND:

Article IV of said Articles of Organization is amended to change the name of the Managing Member from "TAVISTOCK RESTAURANTS HOLDING CORP." to "TAVISTOCK RESTAURANTS GROUP, LLC", by deleting the provision of said Article IV and by substituting in lieu thereof, the following: "The name of the Managing Member of the LLC is Tavistock Restaurants Group, LLC., with its address at 9350 Conroy Windermere Road, Windermere, FL 34786."
