AMENDED AND RESTATED ARTICLES OF ORGANIZATION

Pursuant to the provisions of Chapter 608 of the Florida Statutes, the undersigned hereby declares the following provisions as the Articles of Organization of ORT FAMILY, LLC, a Florida limited liability company (the "Company").


