**ARTICLES OF ORGANIZATION

1. Name. The name of this limited liability company is **BAYVIEW INSURANCE SOLUTIONS, LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.


6. Management of the Company. The management of the Company shall be vested in the managers of the Company.
