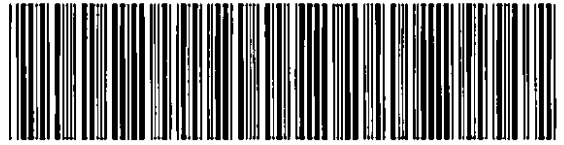

6. The "Converted Entity" is an out-of-state entity not registered to transact business in Florida.


