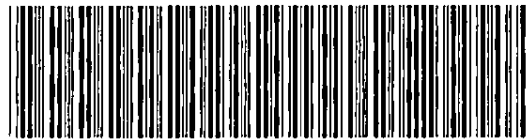

The undersigned, pursuant to the provisions of Section 605.0202 of the Florida Revised Limited Liability Company Act, being a member of Applegate USA, LLC, a Florida limited liability company, hereby amends and restates the Articles of Organization of the Company filed with the Florida Department of State on December 21, 2011, in their entirety to read as follows:

ARTICLE I - NAME

The name of the limited liability company is Applegate USA, LLC (the "LLC").
