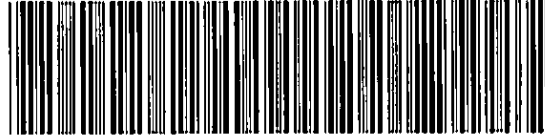

1. Article 1 of the Articles of Organization is amended to read:


**ARTICLE 1
