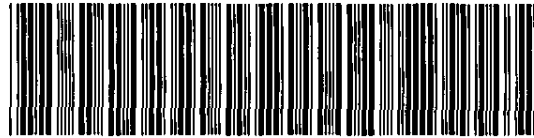

The name of the limited liability company is **Anthony's Coal Fired Pizza of Plantation, LLC**.


