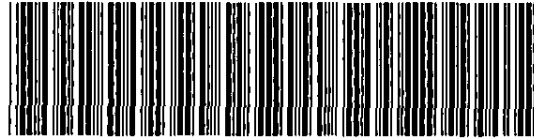



The name of the limited liability company is **Anthony's Coal Fired Pizza of Weston, LLC**.


